Orientation session was conducted for the SY B.Ed student teachers by Mr. Rishi Agarwal Founder and Director, SBI and Co-ordinator Ms. Priyanka Pakhare. Safai bank of India works for the Mission to divert millions of items of multi-laminated packaging waste from reaching dumping grounds of Indian cities. The motto is, "Don't Bin It Bank It" with the aim to provide an effortless platform for millions of families to take responsibility for their waste.

The first collection of the participating schools was more than 2000 MLPs Within a week 2000 plus Multi-Laminated Packages were collected from the internship schools. All the four internship schools are now part of Safai Bank of India and will do monthly collection of MLP

Evidence of success

For the academic year 2019-20 the new initiative under best practice-waste management is in keeping with the theme of the year, 'Building a hope filled future'. Out of the four Universal Apostolic Preferences, The two UAPs that is; To accompany young people in the creation of a hope-filled future; and To collaborate in the care of our Common Home are integrated in the best practice. During the internship program it was observed that the young learners if oriented in the proper direction are willing to work for the betterment of the environment and thus respecting and protecting mother earth for the healthy future. The response shown by the students in collecting Multi Laminated Packages was really over whelming. The Green Marshals appointed to perform the task were more than willing to be part of the initiatives and worked with interest and enthusiasm to collect the MLP

Problems encountered

SXIE's initiative in the area of waste management had dual purpose for the human well-being and for the well-being of mother earth Waste is generated in various forms. It appears that we can deal with this growing mountain of filth: by reducing our waste by using less, and by separating the waste so that we can recycle, reuse and compost as much as possible. While orienting young learners about waste management and related issues it was felt that there is a whole culture of waste management that needs to be put in place. Every component of the society needs to gear up to follow the norms because most of the time citizens ignore the facilities provided by the government to dispose the waste in the appropriate manner. There is lack of awareness about hazardous effects of waste on human health and environment which probably is one of the major reasons not handling waste management with seriousness. It was also observed that we need to work collectively towards bringing changes in the habits of the people. Schools should seriously invest in waste reduction which in not really happening.

Notes

St. Xavier's Institute of Education for the IQAC Best Practice - Waste Management New Initiative for the academic year 2019-20 collaborated with Safai Bank of India, a project by Mumbai Sustainability Centre, which is a Section 8 non-profit company registered under the Companies Act of 2013.

Safai Bank of India is currently working with Multi-Laminated Packaging (MLP) waste only, which is one of the largest types of plastic waste being generated and having poor disposal procedures

- Safai Bank of India collects the MLPs waste from schools and colleges with the help of their logistics and disposal partner NEPRA.
- Once the collection is done SBI store them in their warehouse or dry waste centres.
- Once in a month NEPRA transfers them to the cement factories where it is used in Cement Kiln.
- In cement Kiln the MLPs are co-processed for cement production and due to the high temperature of 1500-2000 degrees it nullifies the release of dioxins.
- Hence the proper disposal of MLPs is done as per the Waste Management Rules of 2016.
